He Mizoram Sorkar Finance Department Oder leh RBI Circular DOR.No. BP.BC.71/21.04.048/ 2019-20 : Date 23.05.2020 angin, kan loanee-ten an loan rulh chungchangah moratorium an rawn dil a nih chuan thla 3 (thum) chhung, June – August, 2020 atan moratorium hi pek theih a ni ang.

Branch level-ah Option No 3388-ah lutin Loan Rescheduling Setting – Account Wise hmangin siam tur a ni a, Passing Option chu 3387 a ni. 
