2. KCC loan ₹ 3.00 lakh chin leh a hnuai lam kan pek dawnin heng – processing charge, documentation charge, inspection charge, Service charge, etc. engmah lak loh tur a ni. Hei hi loneitu harsa leh rethei te te te phurrit siam belh loh nana tih a ni.
3. Anmahni tana tha tur a nih avangin heng KCC beneficiary te reng reng hi Social Security cover – PMSBY leh PMJJBY te hi tihtir ngei thin ni se.
4. KCC Loan application dawn a nih atanga kar 2 chhung aia rei loah loan hi issue fel hman ngei tur a ni.
5. Tun dinhmunah India ram Bank te hian KCC loan hi mi nuaih 36 hnenah ₹ 30,000 crore sanctioned tawh a ni a. Hetah hian keini Bank chuan mi 4 hnenah ₹ 6.96 lakh chiah kan la pe ve a, tan kan lak nasat a ngai hle mai.


